JUVÉDERM® VOLUMA™ XC	Yes The first and only FDA-approved filler to add volume to the cheeks and shape the chin.	Deep injection in the cheek area to correct age-related volume loss and for augmentation of the chin region to improve the chin profile.	Results last up to 24 months
JUVÉDERM® VOLLURE™ XC	Yes	Injectable gels are for injection into the facial tissue for the correction of moderate-to-severe facial wrinkles and folds, such as nasolabial folds.	Results last up to 18 months
JUVÉDERM® VOLBELLA™ XC	Yes	Injectable gel is for injection into the lips for lip augmentation and for correction of perioral lines.	Results last up to 12 months

Restylane-L®	Yes	Reduces severe and moderate wrinkles and folds (nasolabial). Also, approved for lip enhancement.	12 months (6 months for back of hands)
Restylane® Silk	Yes	Lip enhancement and lines around the mouth.	6 months
Restylane® Defyne	Yes	Reduces deep laugh lines (nasolabial and marionette lines). Enhances chin projection.	12 months
Restylane® Refyne	Yes	For severe and moderate wrinkles and folds (nasolabial) and marionette lines.	12 months
